



Fresh Coast Guardians Rain Barrel Giveaway

1. Definition

“District” means the Milwaukee Metropolitan Sewerage District, the regional governmental agency that supports the [Fresh Coast Guardian initiative](#).

2. Eligibility

Any person over the age of 18 that lives in the [District’s service area](#) may participate in the giveaway. Only one prize per household may be awarded.

3. How to Enter

Submit the form on the [Fresh Coast Guardians website](#) with an image or video of your rain garden or Wisconsin native plants in bloom.

4. Giveaway Submission Timeframe

The giveaway will start on August 3, 2023, at 8 am CST and end Sunday, August 13, 2023, at 11:59 pm CST.

5. Selection of the Rain Barrel Winners

- (A) The District will select up to ten winners to receive a MMSD rain barrel. The selected submissions will be selected that best show the use of water-absorbing Wisconsin native plants to help protect our water.
- (B) The District will announce the winner on the District and Fresh Coast Guardians’ social media pages (Facebook, Instagram, Twitter) on or before August 23, 2023.
- (C) The decision of the District regarding winners is final, absolute, and binding.

6. Prize

- (A) [One RainStation, 50*gal EarthMinded*RS50 Rain Barrel](#)
 - 50-gallon capacity
 - Diverter system reduces overflows
 - Reversible “planter lid” is decorative and functional
 - 10-year UV resistance
- (B) The winner is responsible to pick up the rain barrel at the District (260 W Seeboth St – Milwaukee, WI 53204).

7. Cancellation

The District may cancel this contest at any time.



8. Ineligible Contestants

The following persons are not eligible for this contest: District employees or Commissioners, spouses of District employees or Commissioners, and dependents of District employees or Commissioners.
